- Membership **does not include** golf, marina, or pickleball privileges, use of the fitness center, or Helm Club facilities (other than dining).
- Membership Dues are \$1,400.00 plus tax (\$1,491.00 with tax).

ASSOCIATE SINGLE TENNIS MEMBERSHIP entitles:

- One person to limited tennis (*Court time after 11:00 a.m. only Jan 1st through Mar 31st*), Clubhouse Pool privileges, the use of the Compass Rose and Wheelhouse, or special events sponsored by the LYGTC.
- Membership **does not include** golf, marina, or pickleball privileges, use of the fitness center, or Helm Club facilities (other than dining).
- Membership Dues are \$1,750.00 plus tax (\$1,863.75 with tax).

ASSOCIATE FAMILY TENNIS MEMBERSHIP entitles:

- A family (*parents designated for membership and their children 18 years of age and under*) to limited tennis privileges (*Court time after 11:00 a.m. only Jan 1st through Mar 31st*), Clubhouse Pool privileges, the use of the Compass Rose and Wheelhouse Restaurant, or special events sponsored by the LYGTC.
- Membership **does not include** golf, marina, or pickleball privileges, use of the fitness center, or Helm Club facilities (other than dining).
- Membership Dues are \$2,480.00 plus tax (\$2,641.20 with tax).
